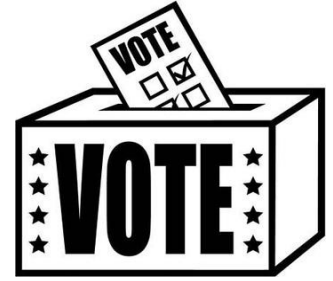




## Super Tuesday, CCNA Style
