



Letter from the President:

Spring is just around the corner and I think we could all use a break from the snow we've had this past winter.

First, I would like to thank Shawn Bales for the excellent snow plowing services he provided to all CCNA residents. By making our neighborhood his priority, everyone was able to get to their jobs safely and we are very thankful for that.

Secondly, as we have mentioned numerous times, approximately two-thirds of dues collected are set aside to pay for snow removal from our neighborhood streets when snowfall reaches 3 inches or more. This year it has been particularly expensive due to the number of snowfalls we experienced.

Thankfully, we don't have high snow removal costs every year, but the years we do, (e.g., 2007 - \$2,200.00 paid) we use much more of the funds from the neighborhood account than we take in for the year. If we have heavy snow removal costs in two or more years in a row, our funds will be depleted very quickly. Meaning.....we would be unable to remove the snow until the funds were built back up again.

It is not forgotten that 2009 and 2010 were very difficult years financially for many and 2011 may still be. In 2010, 136 of the 320 homes in our neighborhood (42.5%) paid their dues.

As of today, only 123 of the 320 homes (38.44%) have paid their 2011 dues. It seems to consistently be the same households paying each year. I would just ask if you can, please consider paying your dues for 2011 so that your neighbors are not paying expenses for those who do not. We have already paid out more in expenses this year than we have taken in and, at only \$1.25 per month the small cost is a true bargain for the services provided.
